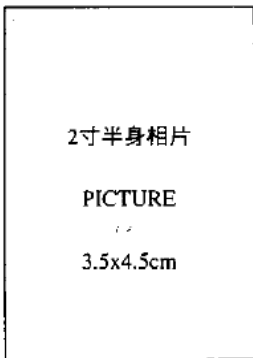

申請簽證之新照片規格 REQUIREMENTS FOR PHOTOGRAPH :

1. 最近 6 個月以內 2 寸半身白底正面衣著整齊的彩色照片 2 張 Two pcs 3.5x4.5cm white background decent attire color photograph, taken within the last six months. 2. 臉部佔據整張照片的 70~80% Image must occupy approximately between 70% to 80% of the photograph. 3. 照片無墨跡、摺痕、污跡、油漬、指印或黏膠印 Photograph free from ink, marks, dirt, grease, finger and paste stains. 4. 照片光源均勻且不能有陰影或閃光反射在臉部 No shading or reflection allowed. 5. 臉部五官清晰呈現，如有痣、胎記、疤痕等均不遮蓋 All facial features should be accurately presented, any mole, birth mark or scar should not be obscured. 6. 相片中人像不得配戴眼鏡或墨鏡，影響辨識人貌，視障者除外 Eyeglasses/shades not allowed, except in the case of medically blind, provided that the applicant can still be recognized through his/her photo. 7. 不得配戴頭巾，人像五官尤其眼部須清楚呈現，宗教因素例外 Head scarf/veil not allowed except for religious and medical reasons, but should not cover the eyebrows/eyes. 8. 相片中人像不得配戴頭帽或其他裝備 Caps/headgear not allowed. 9. 人像不得配戴有色隱形眼鏡 Contact lenses not allowed except for medical reasons, provided that it will not change the color of the eyes.
